## LEVERAGE RATIO DISCLOSURE

This disclosure is prepared in accordance with OSFI Guideline B-12 - Public Disclosure Requirements. The calculation of the Basel III leverage ratio is outlined in the OSFI Leverage Requirements Guideline. The leverage ratio is a simple, transparent, non-risk based ratio that is a credible supplementary measure to the risk-based capital requirements. This calculation provides an overall measure of the adequacy of capital of The Effort Trust Company.
